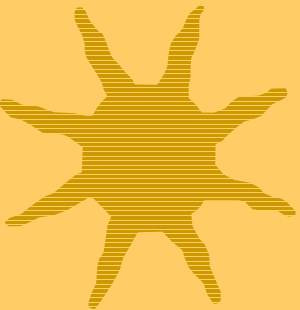

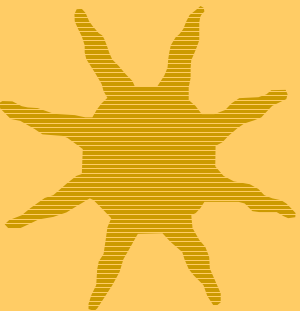


CHILD NUTRITION PROGRAMS

7 CFR Parts 210 and 220



★ Congressional intent that nutritious meals be available to all school children regardless of the household's ability to pay.



★ Code of Federal Regulations, 7 CFR Part 245 outlines eligibility requirements for free and reduced price meals

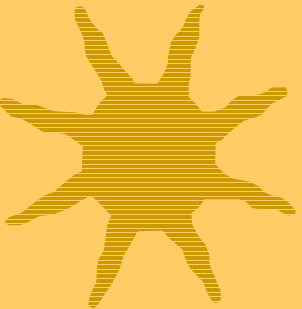


★ USDA is the regulatory agency

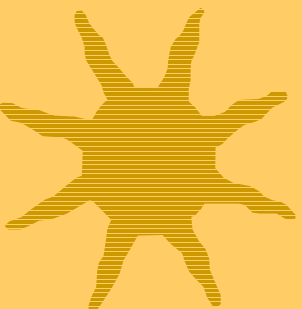
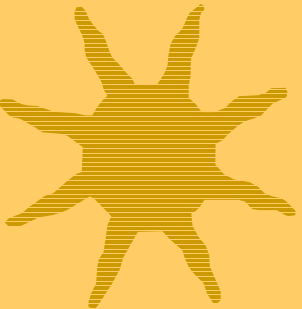
★ SFA's must enter into agreements to operate meal programs to comply with USDA regulations



Free and Reduced Price Policy Statement

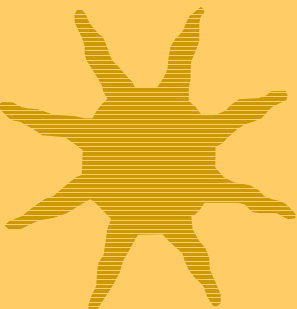
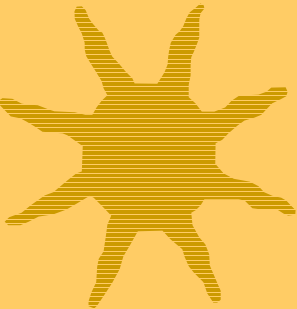


- ★ Names of officials designated to make eligibility determinations
- ★ Assurance that the School Food Authority (SFA) will comply with current income eligibility guidelines
- ★ Description of how the SFA will prevent overt identification of children receiving free or reduced price meals





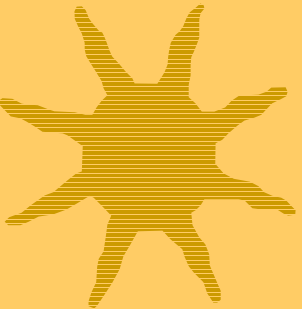
Public (Media) Release



- ★ At the beginning of each school year, public must be notified that the National School Lunch Program (NSLP) and School Breakfast Program (SBP) are available.
- ★ Must include the eligibility criteria
- ★ Must be provided to the local news media



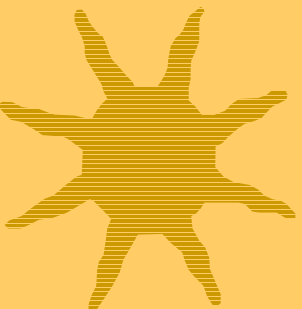

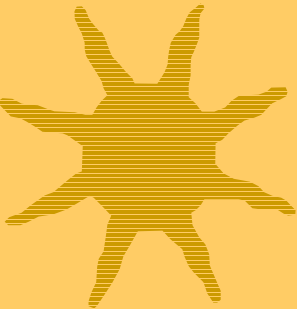
Direct Certification



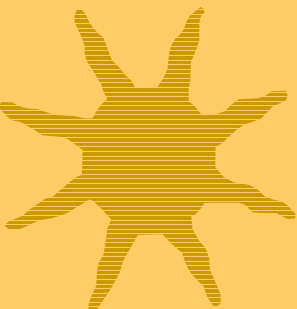
- ★ Simplified method of determining eligibility for free meals without an application
- ★ Department of Public Social Services (DPSS) provides an electronic file containing the names of LAUSD students receiving CalWORKs or food stamps
- ★ If a match is made, the student is identified as eligible for free meals
- ★ Households receive notice of direct certification



Benefits of Direct Certification

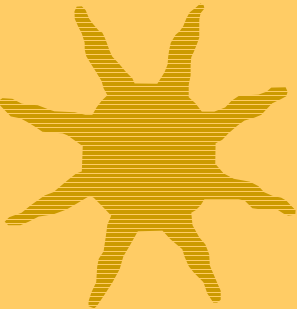


- ★ Customer friendly; no application required
- ★ Reduces paperwork
- ★ No income verification required

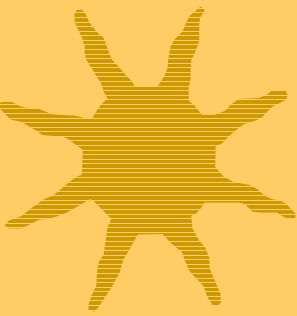
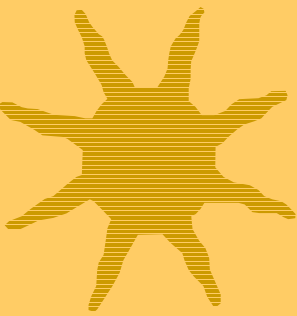

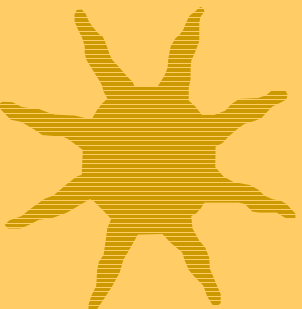
Changes in Direct Certification Status as of 11/7/03

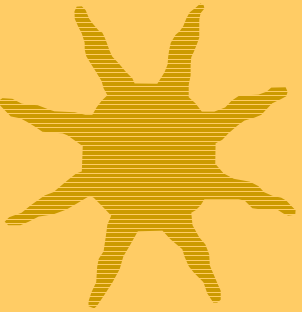

Provision 2



- ★ Applications required only in the base year; 4 year cycle

- ★ All students receive meals at no charge

- ★ Parents not motivated to submit meal application

- ★ Reimbursement based on participation in each eligibility category

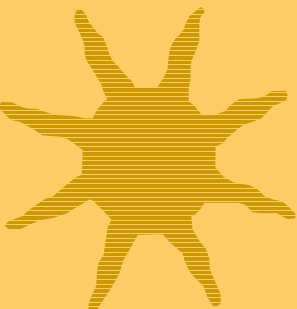
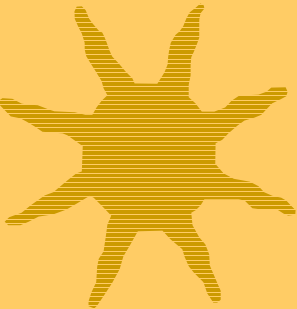
- ★ Revenue minimized if students who are eligible for free or reduced priced meals do not submit meal application; counted as paying students

- ★ Example: \$2.21 (free) compared to \$.23 (paid)





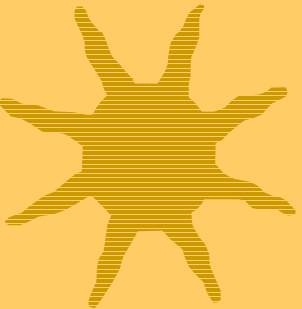
Meal Applications



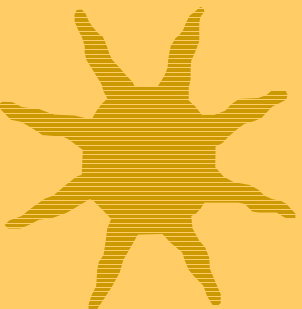
- ★ Must be accompanied by “letter to households” listing instructions on how to complete form
- ★ Privacy Act statement – disclosure of social security number or “none” is required for approval of the application; SSN is required under provisions of the Richard B. Russell National School Lunch Act



Distribution of Meal Applications

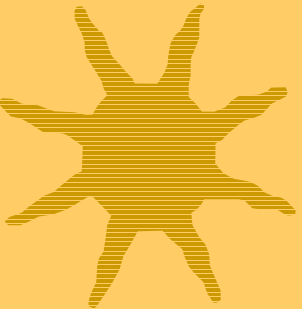


- ★ On or about July 1 or soon thereafter
- ★ SFA's are required to distribute applications at the beginning of the school year to parents of all children in attendance in school except those who were directly certified.



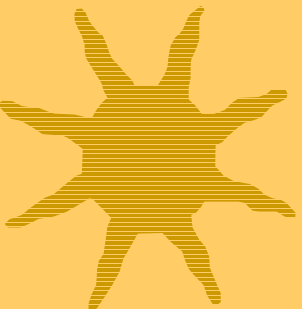
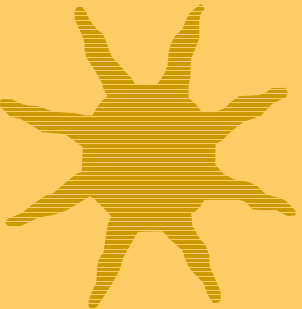

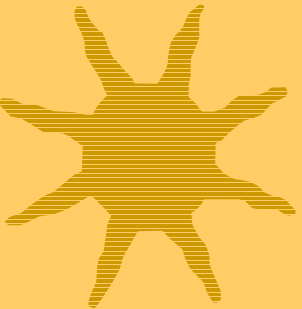
Processing of Applications



- ★ Eligibility determination made within 10 working days of the receipt of the application
- ★ U.S. citizenship is not a condition of eligibility for free and reduced price benefits
- ★ Eligibility may be determined by categorical eligibility (CalWORKs, food stamps, FDPIR, foster child) or by income and household size
- ★ Household must be notified of eligibility

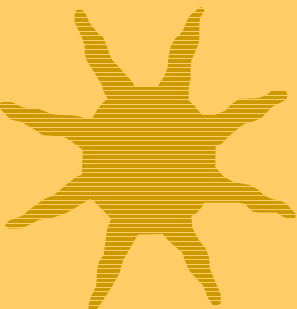
Confidentiality



★ Information on meal application is confidential



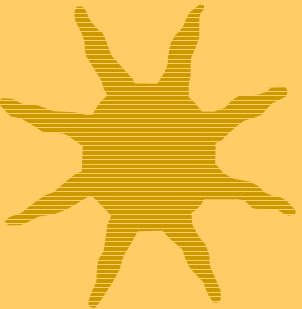

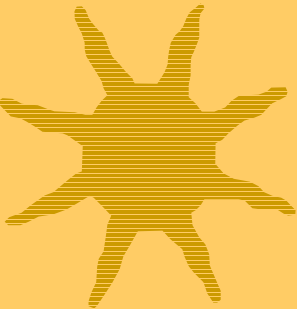
Non-Compliance Issues



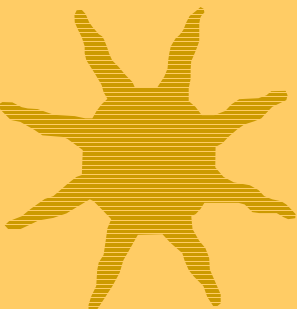
- ★ 7CFR, Chap 11, 245.6 (2): “...the person signing the application certifies that all information furnished in the application is true and correct, that the application is being made in connection with the receipt of Federal funds, that school officials may verify the information on the application, and that deliberate misrepresentation of the information may subject the applicant to prosecution under State and Federal statutes.”



Verification

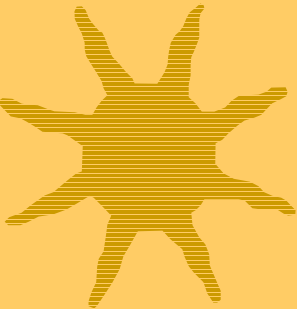


- ★ Confirmation of eligibility
- ★ Annually, SFA must select and verify a sample of applications
- ★ Verification efforts must be completed by December 15
- ★ Under random sampling, the SFA must verify a minimum of the lesser of 3 percent or 3,000 of the total number of approved applications





2002 – 2003 Verification Results



★ Number of Households Verified - 3,103

★ Household cleared – 1,316 (42%)

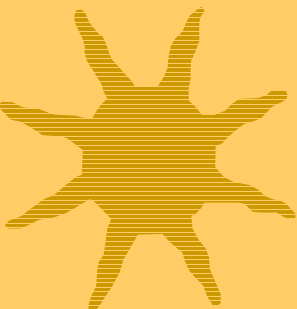
★ Households terminated – 1,787 (58%)

– Withdrew from program – 3

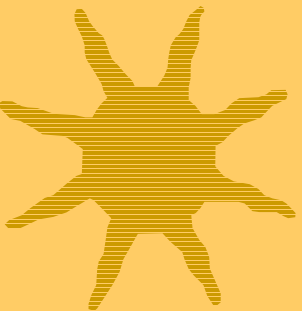
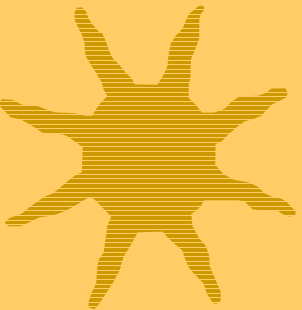

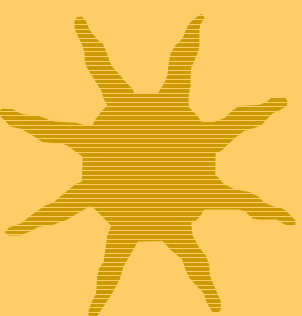
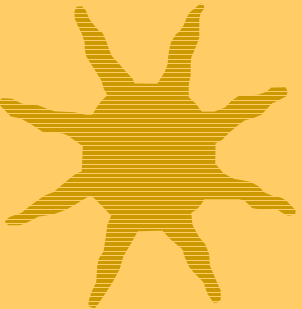
Over-certification

- ★ The U.S. Congress is concerned about the number of children approved for free or reduced price meals who may not be eligible based on other poverty indicators such as the Current Population Survey (CPS).





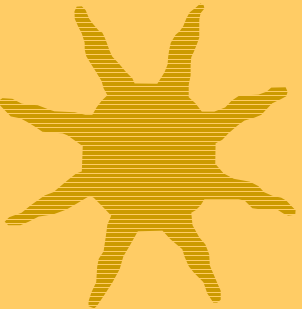
Over-certification



- ★ In 1999, the percentage of children determined to be eligible for free meals was estimated to be 127% of the CPS estimate of school-aged children at or below 130% of the poverty guidelines (income level required for free participation)



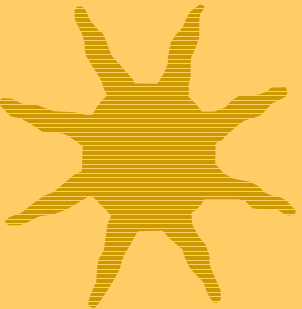
Over-certification



- ★ The USDA's Office of Inspector General determined that in one state nearly 20% of the approved free or reduced price meal applications selected for verification resulted in a loss of those benefits because either the households did not respond or benefits were changed if they did respond.



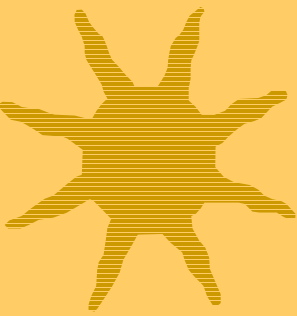
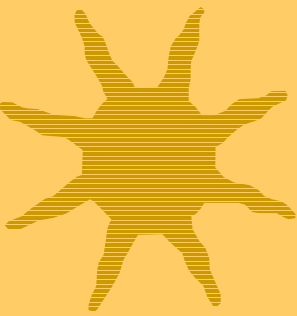
